Thank you for enrolling your child in this year's Safety Township Program. This is Monclova Fire and Rescue's fifth year for this program. We have a lot of fun and educational activities scheduled for the children. We hope to continue this program every year and expand it to meet the needs of our residents. This program is designed to educate children entering kindergarten from 5 to 6 years of age on various safety topics. The topics include School Bus Safety, Animal Safety, Water Safety, Electrical Safety, Fire Safety, Sidewalk and Road Safety, Stranger Safety and Dental Hygiene.

The scheduled dates are as follows:

- June 15 through June 19, 2009
- Scheduled Hours: 12:00 p.m. to 2:00 p.m.
- Location: Monclova Primary, 8035 Monclova Rd.
- Graduation Ceremony on Friday, June 19, 2009 from 1:30 p.m. to **approximately 2:15 p.m.** Parents and family members are encouraged to attend. **The children do have regular class on Friday prior to the graduation.**

There is a cost of \$20.00 per child for this program. The purpose is to help cover the costs of supplies, crafts and staff. 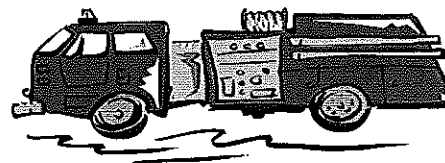
Please read the following requirements that we have set for this years program:

- Only students new to the Safety Township program will be accepted.
- Please drop your child or children off no earlier than 15 minutes prior to the scheduled start time.
- A staff member will check the children in each day. Please indicate if they will be picked-up by someone other than yourself. **Limit of 2 alternates please.**
- Most of the activities require the children to be active and the weather will probably be warm so, allow the children to dress comfortably and casual.
- Make sure you have provided your photo release form with registration.
- Please pick your children up no later than 10 minutes after the end of the scheduled day. **We will require a photo ID** for persons who wish to pick-up a child. Names of the approved alternates must be provided in advance.

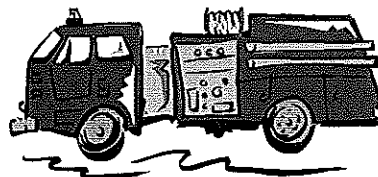
