## CHRISTMAS TREE CURBSIDE COLLECTION

Monclova Township offers residents convenient holiday tree recycling. Your tree must be placed at the curb, following these conditions:

- No plastic bag
- No decorations, i.e. lights, garland
- ONE morning pass through your neighborhood on your designated day.

**North Route: Tree at curb January 3<sup>th</sup> for January 4 & 5 collection.**

**South Route: Trees at curb January 5<sup>th</sup> for January 6 & 7 collection.**

Unsure of your route? It's the same route as your recycling. See page 3 for details.

## WORKING FOR YOU

Happy Holidays from your Monclova Township Elected Officials and staff! As we look back on 2020 we wanted to share some of the work accomplished in the township during the most unpredictable of years.

- Created plans to grow revenue through the creation of two Tax Increment Financing around the future I-475/20-A interchange.
- Initiated plans for 2024 roundabout construction at Salisbury and Holloway to improve traffic flow.
- Spearheaded 2021 road projects for Olde Farm and Clearwater subdivisions, Coder and Salisbury Road.
- Improving our future through updates to the Land Use Plan and Zoning Resolution (see page 2).
- CARES Act funding participation
- Resurfaced and upgraded Wheatstone and Weatherfield Courts and Lexington Glen subdivision.
- Crack sealed 7.5 miles of roads; spray patching
- Conducted 30 burials between the two cemeteries in the township and sold 36 burial graves.
- Cleared the vegetation along Van Fleet Ditch that runs through Keener Park.
- Collected over 6000 cubic yards of fall leaves.
- Fire Chiefs' participation in virtual Technical Advisory Committee meetings for the implementation of the consolidated 9-1-1 / Dispatch operations.
- 1,357 emergency and non-emergency incidents responded to by department personnel, over 3,044 staff hours attributed to incident response.
- 523 Fire safety inspections have been conducted by department personnel resulting in 268 fire code violations identified and corrected.
- Fire Chief and Assistant Chief, in concert with our medical director, developed and implemented safety procedures for all township employees and alternative patient care protocols and operations during pandemic. These continue to be reviewed and modified as appropriate.

## UPDATE ON COMPREHENSIVE PLAN REVISIONS

A Comprehensive Plan is a long-range plan intended to help a community develop a good framework to thrive and prosper. It includes analysis of the community and recommendations for future actions.

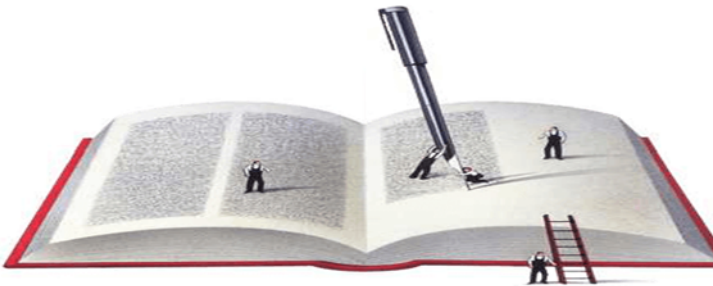

We have a Steering Committee made up of local residents as well as community and business leaders.

## WATER EDUCATION

The public water and wastewater systems in Monclova Township are maintained by the Lucas County Sanitary Engineer's office. Customer inquiries can be made by calling **(419) 213-2926** (24hr/7dy). Although the water and wastewater billing comes from the City of Toledo, operational issues in the public right-of-way (such as water main breaks/leaks, hit fire hydrants, low water pressure, wastewater backups) are addressed by staff of the Lucas County Sanitary Engineer.

In the case of water main breaks, if the repair cannot be isolated (by turning off valves), the Sanitary Engineer may issue a water advisory (advising customers to boil all water intended for consumption only, for at least one minute). This is a precautionary measure where customers would be notified by providing door hangers or other means of public outreach to describe an impacted area. Likewise, a notice will be followed up indicating that the advisory has been rescinded. Two consecutive negative samples (a day apart) would confirm that the water has been sampled and safe to drink.

In the case of wastewater backups, this may be caused within the interior plumbing or service lateral. However, if there is a concern about a blockage in the public wastewater system, please call **(419) 213-2926** (24hr/7dy). We also advise all customers to consider the addition of an insurance rider (covering wastewater backups) on your property insurance. Also, please **DO NOT** flush baby diapers, wipes or personal hygiene items down the toilet. These items tend to clog wastewater mains and pumps at our lift stations along with fat, oil and grease.

Please use the trash can to dispose of grease, rags, wipes, diapers and coffee grinds.

## STAY SAFE

Home fires occur in winter more than any other season. Heating equipment is involved in 1 of every 7 home fires and half of all home heating fire occur in December, January, and February according to the U.S. Fire Administration. Actions you can take to keep your home safe:

- Keep anything that can burn at least 3 feet from heat sources such as fireplaces, wood stoves, and space heaters.
- Plug only one heat producing appliance, such as a space heater, into an outlet. Don't overload the outlet.
- If any appliance in the home burns natural gas or propane, or if you use wood to heat the home, install a carbon monoxide alarm. This is very important.
- Keep a portable generator outside and away from windows. Keep it as far from the home as possible.
- Have qualified, professional cleaners inspect your chimney and vents every year.
- Store cooled ashes in a tightly sealed **metal** container and keep it outside at least 10 feet from your home or other buildings.

Weekly Township Wide Refuse Collection

- N** North Route Recycling - Everything north of Monclova Road.
- S** South Route Recycling - Monclova Road and everything south.
- H** Republic Services Holiday (Collections delayed one day)

#### TRASH SERVICE COVERED UNDER THE CONTRACT WITH REPUBLIC SERVICES:

- Normal household waste for weekly Wednesday collection unless followed by a major holiday, then one day delayed.
- Apartment rentals are not covered under the township's residential services.
- One township-provided trash toter is your limit with our service. Toter limit refers to the specific toter you received from Republic Services.
- Trash must be out by 7:00 AM. Changes in weather, crew assignment, etc. may alter your typical collection, but placement must always be before 7:00 AM.
- Large item pickup: Asterisk (\*) on calendar indicates a possible collection date. You are allowed one large item per month at no cost. At least 48-hour advance notice must be given.
- No construction or remodeling debris.
- No item will be accepted that will harm a sanitation worker or a truck, i.e. pool chemicals, gasoline, steel pipe, excessive weight or container.
- **NO LOOSE GARBAGE** in your toter.
- Recycling service is every other week per your route schedule (N or S on calendar).  
No plastic bags in recycle toter. All items in toter should be loose.

**MISSED?** The truck will not come back if you did not place your toter out by 7:00 AM

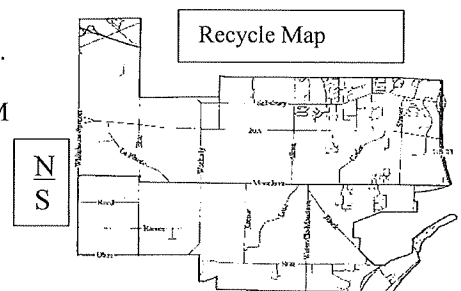
**LIMIT ON TRASH:** One Republic Services toter. No trash bags above toter line or on the outside of your toter. Consider waste reduction through seasonal yard waste disposal at Ohio Compost, 10839 Sager Road, 419-897-7807. This is a fee-free, seasonal drop-off for township residents.

#### DEFINITIONS:

**LARGE ITEM:** Examples-chair, mattress, stove, refrigerator (must have technician verification that Freon has been removed)

**YARD WASTE:** Contained yard waste (in regular trash bag) is accepted in toter. Township Guidelines must be adhered to (watch excessive weight, all items within toter, etc.). Township-provided fee-free seasonal drop-off at Ohio Compost is optional.

**CONSTRUCTION DEBRIS** is not allowed through the township program. This would involve building material, repair, demo
